Dear Ladies and Gentlemen,

The previous year has brought the long expected opening of a number of tender procedures upon the market of infrastructural investments. Nevertheless, the period of extended investment gap has been well taken advantage of by the Trakcja Group. We have successfully completed all restructuring processes, introduced new, contract-type of organisational structure, the company has employed over 300 new employees: engineers, managers, specialist equipment operators and qualified specialists, to a significant extent to meet the demands of the dynamically developing road branch of the Trakcja PRKiI S.A.

Moreover, we have succeeded in strengthening our executive potential through the purchase of a number of machinery units and devices which has also been possible through the complete taking over control over our subsidiary Bahn Technik Wrocław. Additionally we have incorporated a large scale programme devoted to the diversification of executed activities: we continue to strengthen our position within the power supply industry which we entered a few years ago and have succeeded in expanding our activities onto municipal markets thus winning the largest contract marketed last year for the construction of a tram line.

Our international activity is mainly based upon our position in Lithuania as well as entering new markets. In 2017 we initiated activity within the road sector in Ukraine, we became certified upon the German market and thanks to our branch in Sofia we are able to successfully penetrate the Balkan region. The previous year has also resulted in several achievements within the field of innovations. Devices and technical solutions presented during the Trako international trade fairs were recognised by industry experts and won several distinctions within the railroad and power supply sectors.

We make sure to observe the principles of sustained development and respect the goals of all stakeholders in the process of management of the equity group which employs more than 2100 employees and which operates in various regions of Europe. The confirmation of the above has been constituted by re-entering of the narrow group of companies renowned for their corporate social responsibility and obtaining of the Respect Index certificate. Our efforts towards ensuring the best possible conditions of safe working environment have been recognised by the Central Institute for Labour Protection of the National Research Institute thus offering the classification to the Trakcja Group PRKil as the Leaders of Safe Labour. Undertaking of the aforementioned activities has allowed us to strengthen all indispensable pillars of stability and safety of the Trakcja Group.

All of the previous year's successes and attained results prove our broad competences, reliability as well as effectiveness in the process of seeking and undertaking new challenges.

Thus thanking all stakeholders for the trust I kindly invite You to get acquainted to the Annual Report which presents the last year's results.


STRATEGY O

Construction of housing estates and cubature buildings of various uses.



O FINANCIAL RESULTS OF THE GROUP - ANALYSIS OF THE CHOSEN ELEMENTS



In 2017 the Trakcja Group attained results at the level of 323 769 thousands of EUR the level of which was close to the previous year. Gross profit margin generated subject to sales within the aforementioned period amounted to 2,4% and attained the lowest level comparing to the analogical period the previous year i.e. to the value of 4,9%. The projects that are currently being executed upon the railroad sector in Poland have been attained within the period of significant competition already following the launching of the new European Union financial perspective, the fact that translates to lower profit margins. Moreover, the result of decreasing of the gross profit margin generated as the result of sales is constituted by the change of the structure of the order portfolio of Lithuanian companies incorporated as part of the Group. The change of the portfolio of orders is to be treated as a temporary situation. The Trakcja Group attained net profit in the amount of 7 549 thousand EUR.






PRIZES O

The most important prizes and distinctions awarded to the company of Trakcja PRKil in the year of 2017

Systematic striving of the company of Trakcja PRKil towards the implementation of innovative solutions within the executed business activity paralleled by honest and continuous engagement in matters of local societies, employees and from the area of the natural environment, generate thorough recognition and resulted in the series of distinctions, including:

- The medal of the President of the Association of Polish Electricians as well as distinction within the competition of the Jan Podolski Municipal Transport Economical Chamber for "Modular system of dynamic regulation of the load of the catenary substation with the possibility for the connection of charging stations", elaborated in co-operation with the company of My Soft. The main assumption of the system is constituted by the storage of power supply within the periods of intermissions in the concentration of train or tram traffic and thus the possibility for the application of such regained power supply for the needs of for instance charging of electricity propelled vehicles.
- Distinction within the Józef Nowkuński competition organised as part of TRAKO International Railroad Trade Fairs for the system of dynamic information of travellers and the safety of passengers TRAKCJA-SAT HUSAR SIP. The aforementioned system has been for the first time applied upon the railroad station of Łódź Fabryczna and is one of the most advanced solutions in Poland. The technological partner of the solution is the company of Sat System.
- The title of Respect Index awarded by the Warsaw Stock Exchange (Warszawska Giełda Papierów Wartościowych) and the Association of Stock Exchange Emitters (Stowarzyszenie Emitentów Giełdowych) to the companies which in an irreproachable manner convey communication with the market through ongoing and periodical reports as well as through their own communication channels i.e. company websites as well as for socially responsible behaviours with regards to the natural environment, societies, stakeholders and employees.
