

- **Large market**
 - It is estimated that total expenditure on construction and installation works in the Polish railway sectors in 2012–2013 will amount to approx. EUR 3,5 bn. The growth of the planned CAPEX exceeds the sector's available capacity. Total expenditure on roadworks in 2012–2013 is expected to amount EUR 8 bn.
- **Reliable payers**
 - The European Union, the Polish and Lithuanian governments are the actual payers to the Group
